# **Annual Meeting Minutes**



<u>Call to Order</u>: President Mark Schmidt called the March 26th, 2022 annual meeting of the Wisconsin Angus Association to order at approximately 3 PM. The agenda, minutes, and financials were passed out to the 42 attendees.

<u>Secretary Report:</u> Dan Downing moved to accept the minutes from the 2021 Annual Meeting. Kurt Hallstrand seconded the motion. Motion carried.

### New Business

- Mary Jean Hlavac Donation: Ideas and suggestions were taken from the membership for use of the funds of nearly \$40,000 that was donated. Ideas are as follows: Ensure Frank's name is included, Mary Jean and Frank Hlavac were a team. Youth assistance: LEAD travel funds, scholarships, supplies grant, NJAS Showmanship Dress Fund, Traveling Show Award, general award to recognize outstanding Angus individuals in WI, assistance with membership dues.
- Bylaws Amendments: Jeremy Krusemark presented the by-laws to be in-stated, changes from articles of
  incorporation included section 5.1, and section 5.3. Dan Downing moved to accept the by-laws as re-written. Mark
  Tremaine seconded the motion. Motion carried.
- State Leaders Training: Cassandra Garcia reported on her trip to Wooster, OH for leadership training on behalf of the association in January.

**Elections:** Mark Tremaine served two 3-year terms and would not be eligible for re-election. Rodger Schmidt served one 3-year term and did not wish to seek re-election. Jeremy Krusemark and Steven Schank each served one 3-year term and were eligible for re-election. President Mark Schmidt called for nominees for any eligible board nominees. Jack Cummings and Chad Morrissey were presented as expressing interest in serving on the board. Kurt Hallstrand moved to close nominations and cast a unanimous ballot for Jack Cummings, Chad Morrissey, Jeremy Krusemark, and Steven Schank as nominees. Mark Schmidt seconded the motion. Motion carried. Jack Cummings, Chad Morrissey, Jeremy Krusemark, and Steven Schank were elected.
